TO RECEIVE VOTER REGISTRATIONS OF QUALIFIED ELECTORS WHO ARE NOT ALREADY REGISTERED TO VOTE IN THEIR RESPECTIVE CITY.

QUALIFIED ELECTORS WHO ARE UNABLE TO MAKE PERSONAL APPLICATION FOR REGISTRATION MAY REQUEST A MAIL-IN VOTER REGISTRATION APPLICATION FORM. COMPLETED FORMS MUST BE RETURNED TO THEIR RESPECTIVE CLERK OF BATTLE CREEK OR SPRINGFIELD NOT LATER THAN 5:00 P.M. MONDAY, OCTOBER 10, 2017, OR BE POSTMARKED ON OR BEFORE OCTOBER 10, 2017, AS PROVIDED FOR UNDER PUBLIC ACT 441 OF 1994.

VOTER REGISTRATIONS WILL ALSO BE ACCEPTED AT ANY BRANCH OF THE SECRETARY OF STATE OR CALHOUN COUNTY CLERK'S OFFICE.
